There is no charge to view or download these documents from our website. Please note that opinions and dispositions are also available from the PACER system shortly before they are posted to this site. PACER is a fee based system. PACER account holders may register as non-party users of the court's Appellate ECF system to obtain immediate email notification of the filing of opinions and dispositions in specific cases.
